Notice is hereby given that the Trustees of Taurus Mutual Fund have approved the change in the Benchmark Index of Taurus Ethical Fund with effect from May 02, 2013.

Existing Benchmark Index: CNX 500 Shariah

Revised Benchmark Index: S&P BSE 500 Shariah

The change is being effected from the perspective that consequent upon expiry of the licensing arrangement between India Index Services & Products Ltd. (IISL) and Standard & Poor's Financial Services LLC (S&P), S&P is no longer associated with CNX 500 Shariah Index. Further, after establishment of strategic partnership between BSE and S&P Dow Jones Indices, a new Index 'S&P BSE 500 Shariah' has been launched. It is being considered a more appropriate Benchmark Index for the Scheme.

All references to the existing benchmark index in the SID & KIM with respect to Taurus Ethical Fund will be replaced with the revised Benchmark Index i.e. S&P BSE 500 Shariah.

All other features, terms and conditions of the Scheme remain unchanged.

This Notice cum Addendum forms an integral part of the Common Scheme Information Document and Common Key Information Memorandum of the Schemes of Taurus Mutual Fund.
